Introduction

All Christian workers should be able to do pastoral counseling!

The biblical basis for this thesis:

1. The New Testament words for counseling are addressed to *all* Christians.

Parakaleo (107 times in New Testament): encourage, comfort, exhort

Didasko: (97 times in New Testament) teach, instruct (formally or informally)

Col. 3:16

Noutheteo (11 times in New Testament): admonish; counsel

Rom. 15:14, Col. 3:16

Elencho (17 times in New Testament): reprove, expose, convict, refute

Epitimao: (33 times in New Testament) rebuke, warn, tell sternly

Three Basic Counseling Models

	Dynamic Model	Moral Model	Relational Model
Basic presupposition about human nature: Why do people do what they do?	"people are controlled by internal processesof which they are unaware. The roots of these and the source of their current strength are found in the past, in the person's childhood." (Lawrence Crabb, "Understanding People" [Grand Rapids: Zondervan Publishing House, 1987], p. 81)	The basic problem with people is that they are stubborn. Their problems arise from, and only from choices they willfully make.	The basic problem with people is that they have been damaged by bad relationships. "Human problemsare defensive attempts to handle the pain of fear and tension in significant relationships." (Crabb, p. 83)

The Moral model is the most common sub-biblical model found in Christian counseling. Let's look further to see why we must distance ourselves from it.



STAGE 1 -WrongActions/Feelings/Attitudes:

STAGE 2 - False Beliefs:

The chart from Christian Ministry "New Identity" can be very helpful in associating symptoms with wrong beliefs (Caution: don't apply rigidly).

STAGE 3 - True Beliefs:

"Resistance"

"Replacement"

STAGE 5 - Gradual change in habits, thinking, attitude, feelings:

Other considerations when using this model

- 1. This model provides a practical, but not rigid, framework for the counselor/discipler as well as the person who needs counsel.
 - We should not try to just "tell" them what we think regarding each stage. We want to draw them out.
 - ... there are too many variables the person is bringing with them to be rigid.
- 2. As a counselor we should know our own tendencies.

- 3. Conferring with other mature Christians before or during the process of counseling can be very helpful.
